Canabrava Gupta Segment (Capsule Support Segment)

DEVICE DESCRIPTION

Canabrava Gupta Segment (Capsule Support Segment) is a partial ring of clear PMMA covering approximately one quadrant.

INTENDED USE / INDICATION FOR USE

A disposable piece of sterile capsule support segment is used for support of capsule bag during an ophthalmic surgical procedure.

TARGET AGE GROUP

Use All Age Groups

STORAGE CONDITIONS

Store at specified temperature and humidity (Temperature in between 5°C to 55°C and Humidity in between 55% to 75%).

CONTRAINDICATIONS

The device is contraindicated for patients with known plastic sensitivity.

NATURE OF BODY CONTACT

Capsular Bag (Supporting devices for Ophthalmic Surgery)

The device is highly flexible 'C' shaped clear PMMA ring. Each end has a blunt tipped eyelet to aid in insertion of the ring. When positioned in the capsular bag, the ring exerts an outward force that redistributes tension from areas of intact zonules to strengthen areas of weak or missing zonules and support the capsular bag during an ophthalmic surgical procedure. An additional eyelet is used to suture the ring to scleral tissue for better stability of the capsular bag.

HOW SUPPLIED

The Capsule Support Segment is packed in a plastic container and then in a pouch, before sterilization. Such pouch is enclosed within an outer printed box. The overall packaging contains Capsule Support Segment and medical literature insert in an outer printed box, with external identification stickers.

MATERIALS USED

Clear PMMA

CAUTIONS

Do not use the device if the sterilized package is open or damaged.

DIRECTION FOR USE

- Open the pouch of sterile piece of Capsule Support Segment (BYAN UNSTERILE PERSON) and drop the inner container with Capsule Support Segment on a sterile surface without touching it.
- Open the container cap and take out Capsule Support Segment and wash it with saline water.
- Continue with the fixation procedure

The expiration date of the product is the sterility expiration date. The product should not be use after the indicated sterility expiration date.

RETURN OF DAMAGED PRODUCT

Return the product in its original packing identified by the batch number, purchase information, your reference and reason for return. Please contact your local distributor office regarding product return/exchange.
