Fluorescein Sodium Ophthalmic Strip USP

DEVICE DESCRIPTION

A disposable Whatman filter paper No 1 round blunt tip (impregnated with Fluorescein Sodium dye-0.6mg) sandwiched between a sticker paper stick (overall length 60mm). Each strip is packed individually in pouches before sterilization.

INTENDED USE / INDICATION FOR USE

A disposable sterile ophthalmic diagnostic strip is used for evaluating contact lens fitting.

TARGET AGE GROUP

Use All Age Groups

DURATION OF USE

Transient Use (Less than 60 Minutes). It is recommended to withdraw the product after 60 minutes from the patient. The user is accountable for any type of problem taking place in case of use after 60 minutes of the same device.

STORAGE CONDITIONS

Store at specified temperature and humidity (Temperature in between 5°C to 55°C and Humidity in between 55RH to 75RH).

CONTRAINDICATIONS

Do not use with soft contact lenses fitting

INDICATION/INTENDED APPLICATION

Eyeball

MODE OF ACTION

Fluorescein staining of the cornea is performed by first placing a drop of sterile saline on a sterile fluorescein strip. Touch conjunctive or fornix as required with moistened tip The patient blinks to distribute the dye, and the cobalt blue light is used to determine if there are any corneal epithelial defects.

HOW SUPPLIED

Fluorescein Sodium Ophthalmic strip USP are supplied sterile (ETO sterilized), in individual pouches. The overall packing contains Fluorescein Sodium Ophthalmic strips and medical literature insert, in an outer enclosing box, with external identification stickers.
